



If your hours stay high and no cut is received it only means you will have extra money. If you count on the extra money and lose it, it could have devastating consequences for you and your family.


Please take the time to protect yourself from a pitfall that can be avoided.

Can You Hear Me Now?

The Eargo Hearing Aid by Al LaBrecque

Sisters & Brothers: ALERT!

Perhaps you have seen ads for **Eargo**, a hearing aid device, on cable TV. It got my attention when the ads stated **Eargo** is <u>free</u> to **FEHBP** enrollee's plus I found an ad for **Eargo** in the **NARFE** bulletin.

I reached out with this information for Sister Rodriguez. She attempted to contact the company but was only able to make contact through their website. Here is her response to me:

Hi Brother,

They didn't answer when I called. I registered through their website for their free hearing test. Literally you put ear buds in your phone, the test reads sets 3 numbers while different frequencies of noise masks

them. Then you type the 3 numbers you heard on your phone, hit enter, and then listen to the next set.

They don't have brick and mortar stores so that is how you get tested and then they program the hearing aid "ear buds" and mail them to you.

The * after "No Cost", is **Your out-of-pocket costs may vary depending on plan benefits, eligibility, deductible, co-insurance, and model of device chosen. Benefit is not available through all insurance plans. Please consult your plan for coverage details.

It's only free if your health insurance has a hearing benefit that covers the cost in full, but they have a handy dandy financing program if not. I'm pretty sure our "APWU Health Plan", normal hearing benefit would cover this up to the \$1500 every three years with the applicable deductible, coinsurance etc. but it wouldn't get the same negotiated discounts we have with American Hearing Benefits.

The * after "no cost" made me skeptical and it does sound too good to be true.

Not wearing a mask increases your risk of catching COVID-19 by 65%. COVID is increasing everywhere and you have the power to stop it in the Post Office.

"Wearing a mask is an effective and low-cost way to protect ourselves and our families from a deadly disease. It should be — and is — the responsibility of every Michigander. This order reiterates that individuals are required to wear a face covering whenever they are in an indoor public space. It also requires the use of face coverings in crowded outdoor spaces. Most significantly, the order requires any business that is open to the public to refuse entry or service to people who refuse to wear a face covering. No shirts, no shoes, no mask — no service."

The workplace is a public space

"Public place" means any enclosed indoor area used by the general public or serving as a place of work containing two hundred fifty or more square feet of floor space, including, but not limited to, all restaurants with a seating capacity greater than fifty, all retail stores, lobbies and malls, offices, including waiting rooms, and other commercial establishments; public conveyances with departures, travel, and destination entirely within this state: educational facilities: hospitals, clinics, nursing homes, and other health care and medical facilities; and auditoriums, elevators, theaters, libraries, art museums, concert halls, indoor arenas, and meeting

No one in Michigan should be

stating that masks are not required on the workroom floor. This includes rural carriers, letter carriers, clerks and supervisors too!

In addition, the Governor's order states:

"To protect workers, shoppers, and the community, no business that is open to the public may provide service to a customer or allow a customer to enter its premises, unless the customer is wearing a face covering as required by this order."

No window clerk should be given a direct order to wait on a customer who is not wearing a mask.

The Postal Service needs to follow the Governor's orders to help prevent the employees from getting sick.

If your Postmaster or Supervisor is not enforcing the wearing of masks, contact your Steward or Area Director.



My thought, if it is good enough for the US Military, well then it's good enough for me!

I was reading an article on line by the Brookings Institute and thought I would share some of the findings of their review of what is an ever growing call for an increase in the access to vote in all elections using the USPS and a mail in ballot.

The entire article can be found at: https://www.brookings.edu/ policy2020 but I wanted to share a couple of insights from their review of this issue. Given the risks associated with COVID 19 the idea we can vote securely and safely via the US Mail may be an idea whose time has come.

From the article:

How does mail balloting work?

In states that allow absentee mail balloting, the voter writes, calls, or goes online to request an absentee ballot from their local election authority. In some places, voters need an excuse for the absentee ballot such as being sick or out of the state on Election Day. In other places, voters do not need to have a specific reason for the absentee ballot or the state provides the option by mailing absentee ballots to all registered voters. Many states are moving to this system, generally referred to as No-Excuse Absentee balloting.

In making their request, voters have to provide their name and address. After receipt of the request, local election authorities send a ballot to the voter at the home address and provides one security envelope for the ballot that keeps the vote choice private and another envelope into which the sealed ballot is placed. The voter signs the outside of the second envelope to certify he or she is a registered voter.

Upon receipt of the mailed ballot, local election authorities check the name of the voter to make sure the person is registered to vote and is casting a ballot from the address registered with the election authority. After certifying those facts, they remove the sealed ballot from the outside envelope containing the voter signature so that the voter's preferences remain confidential. On Election Day, states count the mail ballots and add the results to the votes of those individuals who cast their ballots in person.

How popular is mail balloting with voters?

In 2020, there has been considerable party contentiousness over mailing balloting provisions. For example, a

plan to have mail ballots sent to every California voter has been challenged in court by the Republican National Committee. The party's stated concern is that mail balloting will undermine election integrity and increase fraud.

Yet mail balloting generally is popular with voters because they don't have to stand in line to cast ballots and they can vote at their convenience in the weeks leading up to Election Day. Fifty-nine percent support holding elections by mail. That reform saves people time and, at a time of a major pandemic, protects their health. The growing use of mail ballots shows how substantially the election environment has changed in recent years and why voters should pay close attention to voting reforms in their particular states.

Does it increase electoral fraud?

If candidates believe there has been voter fraud, they can present evidence regarding a particular race to the election board or file a lawsuit in a local court. Authorities review the evidence and decide if there has been actual fraud. If there is sufficient evidence, local prosecutors can indict the relevant people for mail ballot fraud. It is a criminal offense to forge a name on a mail ballot, impersonate someone else, steal ballots, or deceive someone about their mail ballot.

According to the Brennan Center for Justice at New York University, there is no evidence that mail balloting increases electoral fraud as there are several anti-fraud protections built into the process designed to make it difficult to impersonate voters or steal ballots. These provisions include requiring people requesting absentee ballots to be registered voters, mailing ballots to the official address listed on voter registration rolls, requiring voter signatures on the external envelope, and having

election authorities make sure the ballot came from the address of an actual voter. If a ballot appears questionable, some states use a signature matching technique to verify the signature of the

These steps make it difficult to engage in fraud on a widespread basis. You can't request a ballot for a person that is mailed to your address as opposed to that person's official address with the election authorities. Even if someone wanted to wait by a mailbox for the absentee ballot to be sent to the registered voters so you could steal their ballot, you would never know what day the absentee ballot would arrive because voters can request them for several weeks prior to an election and election authorities send them out as the requests come in.

For years, military personnel stationed abroad have voted by absentee ballot with virtually no claims of election fraud. The procedures that already are in use safeguard against abuse and ensure the integrity of the voting process.

The few cases of voter fraud that have been documented tend to be quite localized. For example, in 2018, North Carolina Republicans were cited for election fraud involving mail ballots. A campaign staff member who worked for Mark Harris in his Ninth Congressional district race was indicted for mishandling mail ballots and directing others to engage in election fraud. The evidence was so widespread that a federal judge invalidated the election and called for a special election.

What are the political consequences of mail balloting?

Republicans fear mail balloting will increase votes for Democrats. They worry that individuals who are part of groups that typically vote in lower numbers will cast absentee ballots because of the ease of doing so. This includes young people, low-income people, minorities, and those without access to transporta-

Yet one group that benefits from absentee ballots is senior citizens, who often skew GOP. Those who are incapacitated or sick can request mail ballots as can those who cannot drive or lack access to mass transit. Mail ballots represent a way for those individuals to exercise their constitutional rights at election time.

Republicans have won in legislative districts having a large number of mail ballots. In a 2020 California special election for Congress, for example, Republicans captured a seat that previously had been held by Democrats. They did so by getting out the vote and making sure their voters had access to absentee ballots.

A major study of California, Utah, and Washington state conducted by Daniel Thompson, Jesse Yoder, Jennifer Wu, and Andrew Hall of Stanford University for elections between 1996 and 2018 concluded there was no partisan advantage to either party based on voting by

There are a variety of studies done but I believe this is the future of voting and in the end as well the security of our mail system provides an opportunity for all Americans to participate in our democracy that is a good thing.



U. S. TROOPS VOTE BY MAIL

Given the fact that the nation will most likely be dealing with the impact of the COVID-19 pandemic well past the upcoming presidential election in November, it is important that the Congress allocate federal funding to States so they can implement a robust voteby-mail option and other measures to ensure all Americans can safely and effectively vote. The reasons for this are obvious. Large numbers of people voting in person makes it hard to follow the CDC guidelines on social distancing. Moreover, during a presidential election many polling locations are more crowded than usual, and people vote with widely shared machines. At least 50 voters and poll workers who were at polling places during the recently-held Wisconsin presidential primary are now infected with CO-VID-19.

If Trump had not avoided military service in Vietnam in 1968, he would have known that the U.S. military and their families have been voting by mail in large numbers since the Civil War, that Congress has been supporting it these past 150 years, and that there have been almost no instances of fraud.

WHITE HOUSE & THE UNION

The U.S. Department of Veterans Affairs (VA) recently announced that it has expanded clinical and office space for serving Veterans by more than 150,000 square feet, while saving taxpayers more than \$1.4 million annually. The expansion and savings are the result of VA's implementation of the May 2018 Executive Order 13837 (EO) which prohibits free or discounted use of government property for union business. VA notified more than 330 local bargaining units late last year that under President Trump's order, they would be required to either vacate VA property or begin paying rent for any VA-owned office space that was being used for union business. In the first quarter of fiscal year (FY) 2020, employees spent 135,000 hours in "official time." But the second quarter of FY 2020 ending in March saw a 56% drop, as just 59,000 hours of "official time" were logged by VA employees. Faced with the prospect of paying fairmarket rent for the VA space they had been using for free, 244 local union bargaining units notified VA they plan to vacate VA premises. VA facilities will use this space for administrative staff in some cases, but in other cases it will become space where Veterans receive care. For example, space freed up under the EO is being used to provide mental health care in Massachusetts, suicide prevention counseling in

Veteran News Pennsylvania and care for homeless, earned through their service. If you, maximum will be \$1,800. The

Pennsylvania and care for homeless Veterans in North Carolina.

Additionally, 77 local union bargaining units have signed yearlong leases with VA and are paying rent to retain space located on VA property, which will result in a total of more than \$1.4 million per year in rent payments that will be directed back to the U.S. Treasury. VA started collecting those rent payments in March. The order also calls for reductions in the use of "official time," which is time during the workday federal employees engage in union activities. VA has made significant progress in this area to ensure VA employees are focused on serving Veterans. What do you think???

BUDDY TO BUDDY VETERANS'

The Michigan Veterans Affairs Agency is putting out a call for volunteers for its new Buddy to Buddy Veteran Mentorship Initiative, which is designed to support service members and veterans of all eras in Michigan in linking them to resources that address a variety of issues. The initiative, which replaces the University of Michigan program of a similar name, is intended to be active in all Michigan Counties and ultimately help service members and veterans thrive in the communities they live, work and play. Their initiative requires a group of volunteers who are passionate about veteran advocacy and can provide service members and veterans one-on-one mentorship. MVAA will provide training on veteran resources and best practices to better troubleshoot a variety of issues from transportation to accessing federal benefits. This initiative is about one veteran helping another. Using mentors to help link fellow veterans to resources is an effective method in breaking down barriers that prevent veterans from engaging in services and care they have

earned through their service. If you know a veteran who may be interested in volunteering with MVAA's new Buddy to Buddy Veteran Mentorship Initiative, please have them contact the Michigan Veterans Resource Service Center at 1-800-MICH-VET to have the application mailed to them.

CVSF EMERGENCY RELIEF

Osceola County will become the latest county to distribute state-appropriated emergency relief aid to veterans. The county is working with the MVAA to secure \$4,200 in Meijer grocery vouchers for veterans and their families through the MVAA's County Veteran Service Fund Emergency Relief (CVSF-ER) program. Through mid-June, 22 Michigan counties had either secured or were working to secure CVSF-ER grants, for a working total of \$1.35 million. The deadline for counties to apply was June 30. Other counties involved in the program so far are Calhoun, Cheboygan, Eaton, Genesee, Gladwin, Gogebic, Ionia, Iosco, Isabella, Kalamazoo, Kent, Lenawee, Marquette, Mecosta, Midland, Missaukee, Muskegon, Oakland, Roscommon, Wayne and Wexford. Veterans can find the Veteran Service Office in their county and learn more about CVSF-ER requirements and what may be available in their area by going to the MVAA web site @ https:// www.michiganveterans.com/ and checking for your VSO in the County you reside in. Contact your VSO for more information.

TRI-CARE DENTAL BENEFIT INCREASE

United Concordia, the TRICARE Dental Program contractor, announced it will be raising every enrollee's annual maximum an additional \$300. For the contract year that runs from May 1, 2020, to April 30, 2021, the annual

maximum will be \$1,800. The change is automatic. Enrollees do not need to take any action for this to apply.

VA & THE POSTAL SERVICE

The U.S. Department of Veterans Affairs (VA) has announced, during national Post-traumatic Stress Awareness (PTSD) month, VA's National Center for PTSD will fund more research about PTSD. This is thanks to the proceeds from the Healing PTSD stamp, which was issued in December 2019 by the U.S. Postal Service. More than 7 million stamps were sold from December 2019 to May, garnering upwards of \$717,000 which have been disbursed to VA.

"Thanks to the millions of Americans who purchased the Healing PTSD stamp, VA will continue to study, create awareness, educate and develop policies which better the lives of Veterans with PTSD," said VA Secretary Robert Wilkie. "The stamp not only raises awareness about PTSD but will provide funding for needed research and education about trauma and PTSD treatment."

Anyone who has seen or gone through a traumatic event, such as war, sexual assault or a serious accident, can develop PTSD. As a result, they may experience problems sleeping, trouble concentrating, recurrent dreams about the trauma, intense reactions to reminders of the trauma, disturbances in relationships and/ or isolation. However, PTSD can be treated. VA offers personalized effective treatments for PTSD including talk therapy and medication. tenance Updates and floor talks on Covid-19 hopefully everyone is receiving these talks. These talks are too important not to receive. Please check with a shop steward or management if you have not received any of the talks on Covid-19. In some offices members tell me, management posts the information on a board, but they do not have time to read them. I am not a fan of talks being posted on a board or handed to an employee and told read this when you get time as often, they do not get read. The 'drive by method' also does not allow for any group interaction or questions. Brothers and Sisters, if you are told to read the talks you must take the time and read them, these topics are too important not to take seriously. I am going to discuss 2 talks that ALL custodians should have read and should be following:

A change in the green CTC cleaner was mentioned in Maintenance Update Volume 22, No. 57 Special Covid-19 Edition, Covid-19 CTC This MMO is a replacement to the Training Material Changes. It states: 'In response to the requirements in MMO-031-20, HQ MP & S has modified and released several Custodial Team Cleaning (CTC) Specialist training materials and procedures.' It also states ...'start using the new chemicals and remove all PortionPac 102 from facilities'. The new cleaner is PortionPac Germicidal Green 232. Has anyone received the update information on this new cleaner? Do you have the new cleaner? Did it just show up without instructions to the proper usage? Ensure your office has this new cleaner and you have been trained on where and how to use the new cleaner. Ensure labels on the bottles have been changed to reflect the new cleaner and the SDS (safety data sheets) have also been updated.

The same Update refers to MMO-031-20 which is a Maintenance Management Order from February 3, 2020.

previous Influenza and coronavirus cleaning MMO-109-09. MMO-031-20 can be found on the covid-19 page at APWU.ORG. I encourage everyone who is not familiar with this MMO or who has not read it to read it, so you know what is required and the purpose. This MMO is required fomite cleaning established using the guidance from the CDC (Center for disease control). This MMO identifies frequently touched items in different areas and gives guidance on whether the items should be cleaned daily or frequently. A few items identified include e-stops, door handles, pens, pencils, scanners, time clock buttons and anything frequently used and shared with others. The custodians are our front line of attack during this pandemic, disinfecting frequently, but the rest of us still need to do our parts and be socially responsible.

Peters Launches Investigation Into Postal Service Delays After Postmaster General Fails To Provide Answers

Following Reports of Slow Mail Delivery, Cuts to Postal Workers' Overtime, & Lack of Transparency from USPS Leadership, Peters Seeks Firsthand Accounts of Postal Problems.

WASHINGTON, DC – U.S. Senator Gary Peters, Ranking Member of the Homeland Security and Governmental Affairs Committee, is launching an investigation into reported delays at the U.S. Postal Service that are preventing Americans from receiving critical mail on-time, including prescription drugs, business mail, and mail-in ballots. Despite repeated inquiries from Peters, Postmaster General Louis DeJoy has failed to provide answers when pressed for details on reported service delays following recent changes directed by Postal Service leadership that could undermine delivery service during a pandemic and ahead of the general election. Peters is seeking additional information from Americans who have seen unexpected changes to their mail delivery to help shed light on the impacts these reported changes are having on the dependable, timely service people count on from the Postal Service.

"For 245 years, the Postal Service has worked to provide reliable, consistent and on-time delivery that keeps Americans connected no matter where they live - especially in rural areas," said Senator Peters. "Unfortunately, in recent weeks, I've heard firsthand from constituents, postal workers and local officials in Michigan who have encountered problems with the timely

and dependable service they count on to conduct business, get prescription medications and critical supplies, and even exercise their right to vote. As Ranking Member of the committee charged with oversight of the Postal Service, I will be working to get to the bottom of any changes that the new Postmaster General may be directing that undercut the Postal Service's tradition of effective service."

As part of his investigation, Peters is asking for individuals, small businesses and organizations who are directly affected by Postal Service delays or operational changes to share their stories. Members of the public can report problems by visiting www.peters.senate.gov/postal. Peters also wrote to his Senate colleagues this week asking them to share reports they receive from constituents on challenges with on-time mail delivery. The next steps of Peters' investigation will include requesting information from those who may have experienced changes firsthand, including senior advocacy groups, state and local officials, local postmasters, postal workers and officials, small businesses and chambers of commerce.

Peters' goal is to ensure that any changes happening at the Postal Service are transparent and do not negatively impact deliveries. Unacceptable changes to service, made without oversight or public input, could harm seniors, veterans, small businesses and people in rural areas who often have less access to other services and rely on the Postal Service for access to medications, emergency information, and home supplies. As increasing numbers of Americans plan to vote by mail in upcoming elections, the Postal Service must also ensure that any operational changes do not limit voter participation.

APWU Members Make Almost 30,000 Calls To Congress

On Thursday, July 23, APWU members and our allies made an incredible 28.156 calls to the senate. That's a phone call every three seconds! Together with calls made direct to Congress, not through the APWU Legislative Hotline, the total was likely closer to 30,000.

This is exactly the kind of pressure we need. Congress holds the key to solving the Postal Service's financial problems during this Coronavirus crisis. We need to work together to make sure the Senate approves at least \$25 billion in aid to keep the USPS running.

We are starting to see this crisis hitting our day-to-day work. The Postmaster General is using it as an excuse to slow the mail. The new PMG policies include reducing hours in retail units including Saturday closings, delaying mail, slowing down service, further removal of mail processing equipment, arbitrarily reducing work hours and eliminating overtime.

With an already understaffed operation, reducing hours and overtime can only lead to severely delayed mail and packages.

There will be more for us to do in the coming days. Here are some thing we can do right now.

• If you haven't called both sena-

tors already, make the call. Ask your co-workers to do the same at 844-402-

- Find out whether your local has a Collective Action Team and get involved. Talk to your stewards and officers about organizing events or actions to save the Postal Service.
- When you suspect the mail is being delayed, report back to your stewards and local officers to help build a picture of how the service is being affected across the country.

We made sure the people we elect heard our voices clearly. Let's keep that pressure up.
